The Bid shall be completely filled in, signed, enclosed in an envelope, sealed, and plainly marked with the Bidder's name, address, and telephone number and the name of the Project. Bids will be valid only when accompanied by a bid deposit in accordance with the requirements of Section 00 20 00, Article 5. The Bid shall be filed with the **City** at 1010 Massachusetts Avenue, 3rd Floor, Boston, MA 02118. The Bid shall be filed before 12:00 PM on the date stipulated in the Advertisement. Bids received after precisely 12:00 PM will not be accepted and will be returned unopened.
3. Bids shall be for the complete work as specified. The Bidder shall be selected on the basis of such Bids.
4. Every Bid shall be accompanied by a bid deposit in the form and amount specified in Section 00 20 00, Article 5. This bid deposit shall become and be the property of the **City** as liquidated damages if, after a contract is awarded the bidder shall fail to enter into the required contract within ten (10) days, Saturdays, Sundays and Legal Holidays excluded, after such notice of award is received by him.
5. Every Bid shall be accompanied by a completed Strategy Form. Failure to complete and include this form with the bid will result in the Bidder being deemed non-responsive.
***PLEASE NOTE THAT THIS IS A NEW REQUIREMENT.**
6. A performance bond and also a labor and materials payment bond, each of a surety company licensed by the Division of Insurance to do surety business in the Commonwealth of Massachusetts and included on the U.S. Treasury list of approved sureties (see Circular 570), and satisfactory to the **City**, each in the sum of 100% of the Contract Price, will be required of the successful Bidder.
7. Subject to the provisions in paragraph 14.5.1, and the requirements of the Bidding Documents, if the **City** elects to award the contract, the **City** will award it to the lowest responsible and eligible Bidder who submits a Bid, without conditions or exceptions, which conforms in all material respects with the requirements of the Bidding Documents, as determined solely by the **City's** and the **Designer's** evaluation of the Bid Form, Bid Form Attachments and Bidder-provided documents.
8. Determination of the lowest Bidder shall be on the basis of the sum of the Base bid and any alternates accepted by the **City**.
9. Upon evaluation of the Bids of those Bidders remaining for consideration for the award, if the **City** disqualifies any Bidder for the award, the **City** will give written notice of the disqualification to that Bidder.
10. Except in circumstances leading to a determination obviously in error or inconsistent with the Bidding Documents, discrepancies or non-conformance on the Bid Form shall be resolved as follows: (a) between words and figures, the written words are binding on the Bidder, (b) between any sum, indicated by the Bidder, and the correct sum, the correct sum is binding on the Bidder; (c) between the product, indicated by the Bidder, of any quantity and bid unit price and the correct multiplication of the unit price times the quantity of Unit Price Work, the unit price bid is binding on the Bidder, and (d) if a Bidder fails or neglects to enter a Bid price in both words and figures, the Bid price entered, whether in words or figures, will be binding on the Bidder.



Rika Smith McNally and Associates is full-service art conservation practice, providing examination, treatment, and documentation of sculptures, artifacts, and architectural elements. Our clients include museums, artists, municipalities, government agencies, corporations, building architects, landscape architects, and private collectors. The firm's specialty is the conservation of outdoor bronze monuments, contemporary art, fine art sculpture, and historic objects.

Rika Smith McNally, Conservator, is a graduate of the Rhode Island School of Design and has a master's degree in conservation from the Winterthur University of Delaware Art Conservation Program. She has a certificate in conservation from the Harvard University Art Museums and is a Fellow of the American Institute for Conservation of Historic and Artistic Works. Her published research includes a study of various wax and plastic coatings in protecting outdoor bronze from acid deposition, the materials and techniques of the Harvard Glass Flowers and Botanical Models, and the preservation of modern and contemporary outdoor sculpture. She recently published a lead article on the conservation of public art in *The Getty Newsletter* (2012).

The firm has a specialty in historic outdoor monument preservation. Outdoor bronze treatments include cleaning, patina repair, protective coating, casting of replacement parts, and long-term maintenance plans. The firm also provides specifications and project oversight for historic ironwork, painted surfaces, brass, bronze, and lacquered metals, with special expertise in replacing aged coatings with new high performance paint systems to replicate historic finishes, and providing long-term maintenance plans.

Ms. McNally has contributed materials study and interpretation of scientific analyses for historic materials and historic paint finish projects, including the pressed tin ceilings and walls at the Wellfleet Preservation Hall in Wellfleet, MA, and the paint finishes for South Wellfleet's Pond Hill School, for Hadley Crow Studio, Orleans, MA and Providence, RI. With grant funding from the Institute of Museum and Library Services, RSM & Associates assessed and treated a 750-object historic industrial wood and steel artifact collection at Stone Hill College and carried out scientific analyses of historic coatings on the steel components.

Ms. McNally was the Historic Preservation Consultant for the MBTA's Copley Headhouse, located in front of the Boston Public Library, researching the original patina and subsequent paint layers. She also provided condition documentation, vibration analysis, and mitigation strategies for the Tiffany glass windows at the Arlington Street Church, in Boston during

underground subway construction. The firm carried out vibration recordings and mitigation advice for the MIT List Visual Arts Center during recent roof re-placement. Rika Smith McNally provided consultation on the preservation plans for the Franklin and Blackstone painted iron Fountains in Boston. In 2012, RSM & Associates carried out a technical study of the 1794 Daniel Raynerd painted and gilded cast Keene cement eagle sculpture in Faneuil Hall in Boston. RSM & Associates takes and prepares sample, and provides precise analytical queries, followed by interpretation of results. The Research Laboratory at the Museum of Fine Arts, Boston provides the majority of scientific materials analyses for RSM & Associates, using SEM, FT-IR, or gas chromatography.

Additional recent outdoor bronze conservation treatments include the *Johnson Gate* on the Fenway in Boston, Anne Whitney's *Leif Eriksson* Monument and Olin Levi Warner's *William Lloyd Garrison* on Commonwealth Ave, Thomas Ball's *Emancipation Proclamation*, and the Salada Tea Company's Gorham-cast monumental bronze doors on the Liberty Mutual Building in Boston. RSM & Associates also performed the conservation of the *Hannah Duston Memorial* and *Il Pensiero* in Haverhill, and H.H. Kitson's *Roger Conant Memorial* in Salem. Previous outdoor bronze conservation treatments in Newburyport include *George Washington*, *William Lloyd Garrison*, and the *Soldier's Monument*.

Recent artwork conserved by RSM & Associates includes work by Fernando Botero, Jaume Plensa, Meredith Bergmann, Claes Oldenberg, Javier Marin, Richard Texier, Leslie Fry, and Mags Harries.

Rika Smith McNally has also been a guest lecturer in the Wellesley College Museum Director's Class and the Tufts University Museum Studies Program, and has presented workshops at the American for the Arts annual conference and the New England Foundation for the Arts. Recent awards include a 2012 New Hampshire Preservation Award for the restoration of the *Parson Main Monument* in Rochester, NH and a 2012 Boston Preservation Alliance Award for preservation and design consulting of the *Statler Fountain* in Boston for Halvorson Design Partnership, Inc.






